Delinquent Filers

Municipalities are required to annually submit financial statements to the Secretary of State under ORS 297.425. Municipalities with expenditures less than \$150,000 for the year may submit a summary of financial transactions (In Lieu report). Municipalities with expenditures greater than \$150,000 but less than \$500,000 may submit financial statements reviewed by independent accountants (Review reports). Municipalities with expenditures greater than \$500,000 are required to submit audited financial statements. Audit and Review reports must be received by the Secretary of State within 180 days from the end of each fiscal year, which for most municipalities is no later than December 31, unless a request for extension of time has been granted.

Listed below are the municipalities that have not submitted the required financial report for the filing years listed **as of December 11, 2023**, and do not have an approved extension of time to file. Reports may be viewed on our website at: https://secure.sos.state.or.us/muni/public.do. As noted, some municipalities have failed to submit required documents for multiple years. **Per statute, we will notify the county to begin dissolution proceedings of special districts who fail to file for three consecutive years (ORS 198.345).**
