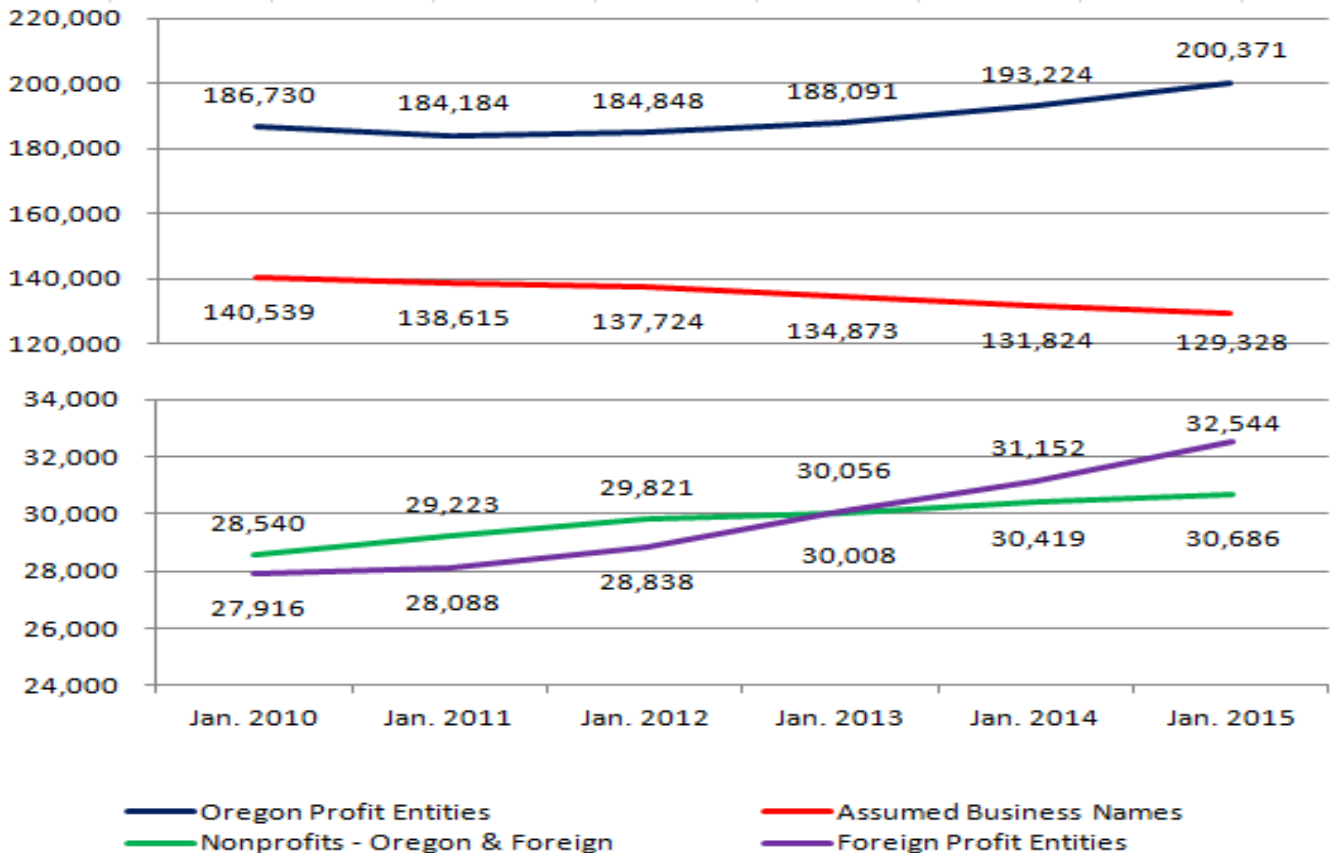


# ACTIVE BUSINESS REGISTRATIONS IN OREGON



**Oregon Profit Entities (\$100):** include all active business corporations, cooperative corporations, professional corporations, water district corporations, limited liability companies, limited liability partnerships, limited partnerships, and business trusts created under Oregon law.

**Assumed Business Names (\$50):** include active 2-year assumed business names registered under Oregon law.

**Nonprofits (\$50):** include all nonprofit corporations created under law in, or outside of Oregon.

**Foreign Profit Entities (\$275):** include all active business corporations, professional corporations, limited liability companies, limited liability partnerships, limited partnerships, and business trusts created under laws outside of Oregon.
