Dear Sir:

I have been advised by the Oregon State Defense Council to first contact you relative to a very serious problem we have in Salem in providing service men with sleeping quarters during the times they are on leave from Camp Adair.

I made some personal investigation regarding this problem over the last week end and find that there were approximately five hundred men in Salem who could not find any accommodations for staying over night. As a result, they were forced to stay in bus and railroad waiting rooms and such other places as were available. It is our desire to remedy this problem as soon as possible, but have been advised to contact you before proceeding with any independent plans for Marion County.

I would be pleased if it were possible for you to come to Salem to discuss this matter in detail, preferably some evening when representatives from other interested agencies might also receive the benefit of your advice.

Dear Mr. Conley:

I have your letter in regard to the housing problem caused by the soldier impact in Salem, Oregon. I have been greatly interested in that problem and have attended a number of meetings regarding it.

For your information, Mr. Will Crawford, State Economic Counsel, Capitol Building, Salem, is Chairman of the Salem Soldier Housing Committee. Mr. Crawford got the City of Salem to donate \$6,000.00 to purchase beds and bedding, which were placed as follows: 120 in the St. Josephs Church and 80 in the Y. M. C. A. The USO will act as operators of the housing needs.

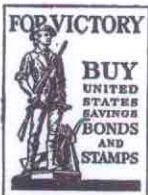
The USO has also listed approximately 190 people to provide housing in the homes of Salem.

In speaking to Mr. Crawford yesterday, he informed me that the State Government has released 50 sleeping bags to the Salem USO to help further solve the problem. Plans were also under way in Salem to put beds in the old city hall, but due to certain reasons, I do not believe it will be used.

The Federal Security Agency, at the present time, cannot authorize government funds to help this problem. Anything that is done along this line will have to be by the local community. I have talked to Mrs. St. Pierre and have told her of your problem, and I am sure Mr. Walter May, State Defense Chairman, is also aware of it.

I do not feel that you will ever fully solve this overnight housing in Salem because you have too great soldier impact. I have told the mayor that the only possible solution that I could see for Salem, was to put in a curfew law which would automatically make the soldiers return at a given hour. The mayor did not wish to do this if there were any other way to solve the problem. For your information, all towns in Oregon have that curfew law and it is an Army must when the city council passes any laws of that type.

If there is anything found that I can do, please advise me. May I suggest that you get in touch with Mr. Crawford and I believe he can give you a more clear picture.

I can assure you that these repairs and changes are most urgently needed on account of present inadequate facilities aside from sleeping quarters and on account of the large crowds which are now coming to Salem. I would appreciate it therefore, if you could use all means possible to expedite the approval and financing of the changes mentioned in the letter submitted by the Mayor's committee.
