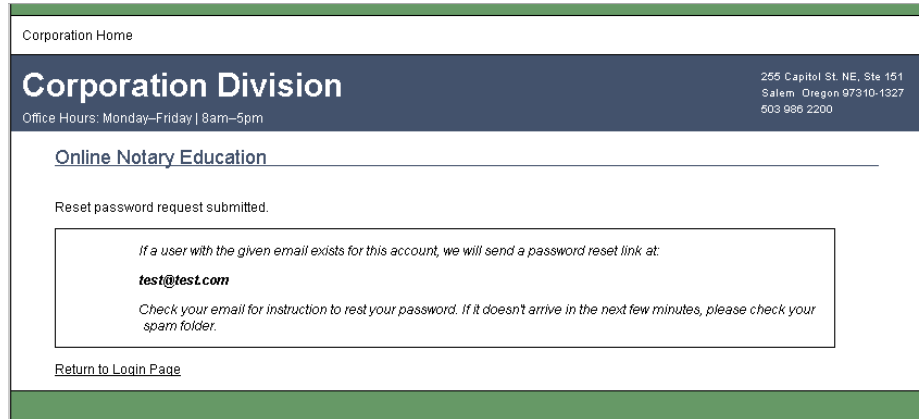

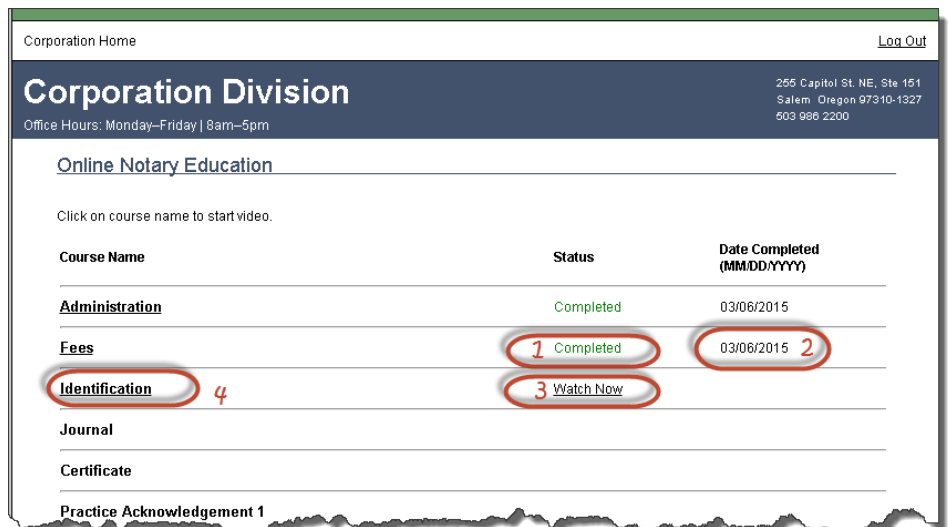

Main course page

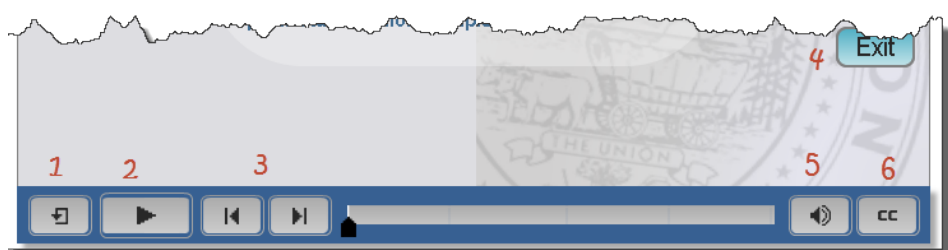
1. Shows you completed the course.

Journal Entry Requirement

- By law, a Notary is required to keep a journal entry of at least the following notarial acts:
 - Acknowledgment of Signature
 - Individual capacity
 - Representative capacity
 - Witnessing a Signature
- ❖ The Secretary of State's office strongly recommends recording all notarial acts in your journal, including:
 - Certifying or attesting a copy of a document
 - Affidavits
 - Administering an oath or affirmation
 - Verification upon oath or affirmation

By law, a notary is required to keep a journal of the notarial acts they perform.

Terry Trueheart, an autograph collector, has an original handwritten song dated January 24, 1965, and signed by the artist, that he wants to sell. Rather than sending the original, the Verification Unit at Music U.S.A. has asked him to send a certified copy for them to examine. On December 2, 2011, at 8:30 a.m., Terry takes the song into the Salem branch of his Credit Union in Marion county, where he has an account, and asks for a notary. Customer Service Representative Jane Doe comes to help. Terry has provided his Siletz Tribal ID card issued 2/4/2005 with no expiration date as identification. How should the notary proceed?
