NEED FOR THE RULE(S)

An amendment to this rule is necessary because SB1533 (2024) revised the formulas used to determine which languages state and county voters' pamphlets must be translated into. The current rule references a fixed number of languages, which no longer aligns with the updated statutory formula in ORS 251.167. As amended, this rule will specify data sources the Secretary of State uses to compile lists of the most commonly spoken languages other than English and the estimated numbers of individuals who speak each most commonly spoken language other than English as required by ORS 251.167. Amending the rule ensures compliance with the updated statutes, eliminates the need for future amendments if the formula changes again, incorporates grammatical improvements, includes statutory references, and re-organizes the rule for clarity.

STATEMENT IDENTIFYING HOW ADOPTION OF RULE(S) WILL AFFECT RACIAL EQUITY IN THIS STATE

This rule promotes racial equity. SB1533 includes requirements for the Secretary of State to ensure that each state voters' pamphlet and each county voters' pamphlet be translated from English into the most common languages of the state and of each county. Translation of voters' pamphlets promotes racial equity by providing citizens in Oregon who have a limited ability to read, speak, write, or understand English with meaningful access to voter information and to fully exercise their voting rights.

FISCAL AND ECONOMIC IMPACT:

The fiscal and economic impact of the proposed amendments to this rule is expected to be minimal.

RULE SUMMARY: This administrative rule outlines the data sources the Secretary of State uses to compile lists of the most commonly spoken languages other than English and the estimated numbers of individuals who speak each language. The Secretary of State uses this to translate the state voters' pamphlet and county voters' pamphlets under ORS 251.026, ORS 251.167, and ORS 251.170. The proposed amendments include the addition of statutory references and also re-organizes for clarity.

Language Lists for Translation of ~~Selected~~ State and County Voters' Pamphlet Materials

~~(1)-This rule despecifines the process by which data sources the Secretary of State creates lists of languages to be used to translate Selected~~ Suses to compile lists of the most commonly spoken languages other than English and the estimated numbers of individuals who speak each most commonly spoken language other than English as required by ORS 251.167. Certain state and Ccounty Vvoters' Ppamphlet Materials- information will be translated into the languages in the lists as required by ORS 251.170.¶

~~(2)(a) The Secretary of State shall uses data about state and county populations to determine the Top Five languages in the state and in each county in Oregon- most commonly spoken languages. The most commonly spoken languages are determined based on the number of people with limited English proficiency who self-evaluate their ability to speak English as less than very well.¶~~

~~(ab) The data sources may used~~ include the most recent American Community Survey (ACS) from the United States Census Bureau, estimates from the Population Resource Center at Portland State University, and other data sources that the Secretary of State determines are available and appropriate.¶

(b3) The data sets obtained from the American Community Survey shall include estimated numbers of people with Limited English Proficiency who self-evaluate their ability to speak English as "less than very well."¶¶

(3) ~~Based on~~In addition to the list of languages described in section (1) of this data~~rule~~, the Secretary of State ~~shall~~will compile the following language lists and make them available on the Secretary of State's website: ¶¶

(a) a list of the state's Top Five languages and estimated numbers of speakers; ¶¶

(b) lists of each county's Top Five languages and estimated number of speakers in each county; ¶¶

(c) the State List of Languages; and ¶¶

(d) the County Lists of Languages.¶¶

(4) The Secretary of State shall update the language lists at leand publish on the Secretary of State's website the list of languages certain filers may submit filings in for inclusion in translated voters' pamphlets ast once every five yearsoutlined in ORS 251.170.
