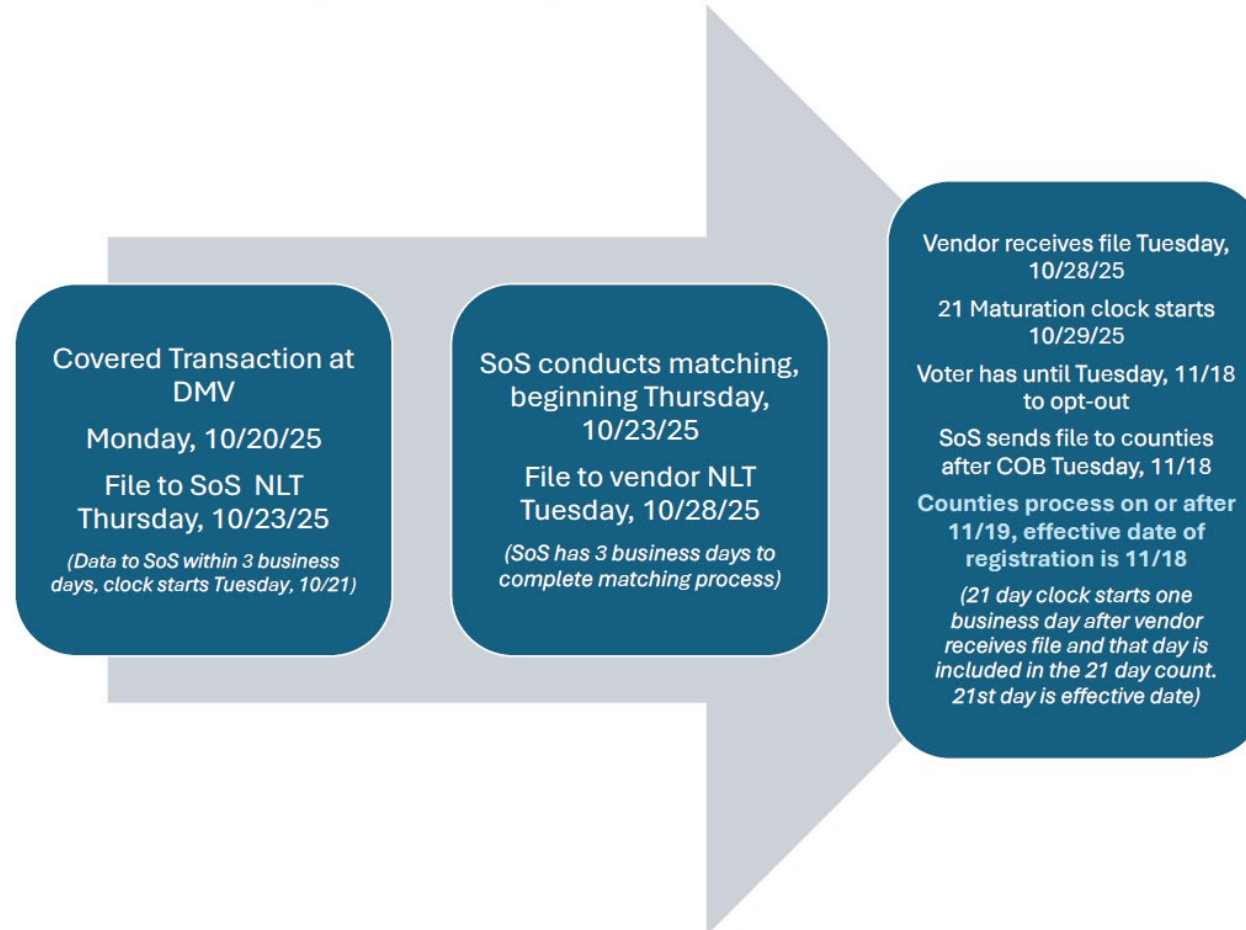
- Draft rules presented in mid-November will address:

 - Registration updates through OMV
 - Updating Information for Active Voters
 - Updating Information for Inactive Voters
 - Change of Address Process

SoS OMV File Processing- RAC Takeaways

- Draft rules presented in mid-November will address:
 - Notice requirements
 - No collection of declination reason
 - Include information about penalties for registering when not qualified
 - Collection of phone/email for follow-up purposes
 - SoS matching timeline
 - Implementing 3-working day rule
 - Vendor timeline
 - Identifying when 21-day maturation clock starts
 - Delivery method
 - Forwardable mail with postage paid return portion

 - Providing alternative methods for OMV participants to return mailers
 - Providing clear instructions for card processing related to the following items:
 - Undeliverable
 - Party Selection
 - Declination
 - Other/MISC

Escalating, Tracking, and Reporting- RAC Takeaways

Draft rules presented in mid-November will address:

- Method for County to notify SoS of issues with OMV data.
- Method for SoS to notify DMV of issues with OMV data.
- Method of tracking and reporting OMV errors.
- Method for voter to notify SoS that they have opted out of OMV in the past.
