# Oregon Voter Registration Card

you may use this card to:

→ register to vote in Oregon

The deadline to register to vote is the 21st day before an election.

→ change your name, mailing address, residence address or political party affiliation on your voter registration

→ become eligible to sign petitions, including initiative, referendum and recall petitions

how to register to vote

→ Fill out the form using black pen and print clearly.

If the form is incomplete, it may be rejected.

→ Sign the form.

→ Mail or drop off the completed form at your County Elections Office.

Addresses are on the back of this form.

Your County Elections Office will mail you a Voter Notification Card to confirm your registration.

selecting a political party

Some political parties require you to be registered in their party to vote for their candidates at a Primary Election.

identification

New laws require that people must provide identifying information to register to vote.

If you have a current, valid Oregon DMV Driver's License/ID, you must provide that number in section 4.

A suspended Driver's License is still valid, a revoked Driver's License is NOT valid

If you do not have a current, valid Oregon DMV Driver's License/ID, you must provide the last four digits of your Social Security number in section 4a.

If you do not have a current, valid Oregon DMV Driver's License/ID or a Social Security number, you must affirm this by marking the boxes in sections 4 and 4a, and if you are registering by mail, you must provide a copy of one of the following:

→ valid photo identification

→ a paycheck stub

→ a utility bill

→ a bank statement

→ a government document

→ proof of eligibility under the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) or the Voting Accessibility for the Elderly and Handicapped Act (VAEH)

information disclosure

Information submitted on an Oregon voter registration card is, by law, public record.

However, identification information submitted in boxes 4 and 4a is, by law, held confidential.

assistance
