

B**Initiative or Referendum Petition**

This set of search criteria allows you to find the chief petitioner committee sponsoring an initiative or referendum petition. This can be done by selecting the year and petition number or by entering a word contained in the title of the petition.

C**Recall Candidate**

This set of search criteria allows you to find the chief petitioner sponsoring a recall petition by entering the last name or first name of the public official subject to the recall.


