Kinds of Evidence Which May Be Submitted in Support of the Registration of a Delayed Birth Certificate

- 1. **Baptismal, Cradle Roll, or Other Church Record.** This may be the original record, a copy thereof containing the church seal, or notarized typewritten or photostatic copy of a church record bearing seal of Notary Public and statement by the notary.
- 2. **Family Bible Record.** Notarized copy of Bible record bearing seal and statement by Notary Public showing name, date of birth, and general appearance of the record as regards its age, presence of erasures or alterations. Publishing date of Bible should also be shown. (Bible records will be considered as Class B evidence unless proved beyond doubt to have been made before the 4th birthday of the registrant.)
- 3. **Physician or Hospital Record.** An exact copy (preferably photostat) of the office record of the physician who attended the birth, or a copy of the hospital record of the birth. Copy must be sworn to before a Notary by the attending physician or by custodian of the hospital records.
- 4. **Birth Certificate of the Registrant's Child.** Certified copy of birth certificate which contains the official seal of the custodian of such records, provided it includes the fact or facts for which it is submitted as evidence.
- 5. Record from a Federal Census. This record may be obtained from Census Bureau at Washington, D. C.
- 6. **School Record.** Notarized copy of school record or record of city, county or state department of education.
- Insurance Policy. Original insurance policy or notarized copy of the application for insurance policy.
 Class A Records are records established before applicant's fourth birthday.
 Class B Records are records established five or more years prior to application.

With one Class A document proving age, birthplace, and parentage, only one Class B document proving age and birthplace is required.

If no Class A document is available, then three Class B documents proving age and birthplace, and two proving parentage, is necessary.
