


OREGON REVISED STATUTES § 63.787: "A domestic limited liability company, and a foreign limited liability company authorized to transact business in this state, shall by the limited liability company's anniversary deliver to the office of the Secretary of State for filing an annual report..."

If the business entity is still in active status, W.C.S., a third-party private entity, will assist for a fee in the filing of your annual report.
