The Secretary of State in carrying out the duties of the office shall issue detailed directives necessary to maintain uniformity in the application, operation and interpretation of Oregon election laws (ORS 246.110 and ORS 246.120). The information provided here is an official directive of the Secretary of State for Clackamas County to conduct an additional hand recount of the ballots cast in its 2022 Primary Election.

### Background

Clackamas County's May 17, 2022 Primary Election was conducted under unprecedented and extraordinary circumstances. A majority of the ballots were misprinted, resulting in barcodes that tally machines could not read. This required the County to duplicate tens of thousands of ballots before machine tallying. In order to certify results on time, the County required hundreds of additional staff, an emergency response from the county government, added security measures, several revisions to the security plan, and increased oversight by the Secretary of State's Office.

### Directive

To verify the accuracy and uniformity under these circumstances, Clackamas County shall conduct additional hand recounts as outlined in this directive and attached instructions.

### Timing and Relationship to Regular Hand Count

This directive requires recounts in addition to the hand recounts required for every county for every statewide election under ORS 254.529 (see directive 2022-04). The hand recounts under ORS 254.529 and the additional hand recounts under this directive shall be conducted simultaneously to the extent possible.

### Specifications for Additional Hand Recount

The County's additional hand recount shall consist of the following:

- The County's additional hand recount shall follow the instructions attached to this directive. All batch hand recounts shall include verification that duplicated ballots were transcribed accurately from their original.
  - County shall use the "SEL 798 Clackamas" form attached to this directive to verify duplication accuracy.
- The County shall hand recount the contests and batches that are listed on page 2 of this directive.
  - The six required countywide contests and the ten required precinct committee person contests were randomly selected for this additional hand recount.
  - The required batches, which were also randomly selected, represent ten percent of the selected contests.

- Except as described in this directive and the attached instructions, the additional hand recount shall be conducted as required by ORS 254.529.

The County shall complete the hand recount as described in this directive by June 23<sup>rd</sup>, 2022 or a later date, if requested by the County and agreed to by the Secretary of State.
